### **The BID levy**

In 2016, businesses within the Putney BID boundary voted to create a Business Improvement District (BID) for the five year period 2017-2022. The Putney BIDCo Limited Company trading as Positively Putney Business Improvement District became operational in April 2017.

To fund the work detailed in the Putney BID business plan each business within the BID area must pay a compulsory contribution, referred to as the BID levy. Payment of the BID levy is compulsory for all businesses within the boundary that occupy premises with a rateable value of £10,000 or more.

The levy will be charged annually for each chargeable period which will be April to March each year. This bill is for the period 1st April 2019 to 31st March 2020. The liability is with the occupier as of 1st April for the full year. No

refunds will be available on the levy charged. The levy must be paid in one payment.

The Putney BID is not responsible for the collection of the levy as this is done on our behalf by Wandsworth Borough Council. Although separate from business rates, the levy's collection is enforced and collected under the same rules.

BID regulations state that levy collection should use the same information for billing as the business rates list. Therefore, levy bills will arrive at the same addresses used for business rates bills.

The BID levy bills will arrive separately to the business rates bills. One levy bill will arrive for each eligible property on the rating list, so a business occupying three rateable properties may well receive three bills.
